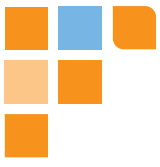

Tokyo is the capital of Japan, where the country's political, economic, and cultural infrastructures come together. Right in the geographical center of Tokyo is Tachikawa City, where people gather together for bustling, friendly exchanges. This is where the Tachihi Group operates its real estate business. Our mission is to contribute to the community as it matures together with the town.

President's Message



The Tachihi Group's predecessor is Tachikawa Aircraft Company Limited, which employed more than 42,000 personnel at one time and manufactured around 10,000 aircraft in about 50 models, including the Akatombo trainer and Hayabusa fighter. When the Pacific War ended, the properties belonging to the company were confiscated by the General Headquarters of the Allied Forces. By the time the properties were fully recovered in 1977, Tachihi had initiated its primary engagement in the real estate leasing business.

In 2012, the Group was restructured by simultaneously privatizing two publicly listed companies, Tachihi Enterprise Co., Ltd., and New Tachikawa Aircraft Co., Ltd., in order to resolve the problems the Tachihi Group was experiencing in terms of its capital and business policies.

Upon privatization, the Group promised the market that it would contribute to the local community through integrated development projects involving Group properties, and has actively engaged in various projects and events beneficial to the residents. These undertakings include LaLaport Tachikawa Tachihi (December 2015, a joint project with Mitsui Fudosan Co., Ltd.), Tachihi Beach (July 2017), Arena Tachikawa Tachihi (October 2017), Fuji Akatombo Nursery School (April 2018), Dome Tachikawa Tachihi (August 2018), the Grand Sumo Summer Tour, Ogasawara School Yabusame (Japanese horseback archery), and the Toray Pan Pacific Open Tennis Tournament 2018.

In February 2015, the Tachihi Group acquired previously nationally-owned property comprising roughly 3.9 hectares (called the Midori Area) located north of the JR Tachikawa Station. Renamed GREEN SPRINGS, this urban subdivision houses the TACHIKAWA STAGE GARDEN – a massive 2,500-seat event hall, the SORANO HOTEL, and other properties.

We feel a great sense of responsibility regarding our roughly 980,000 square meters of land located in the center of Tachikawa City. This is because we acknowledge that our integrated development projects involving the properties will have an impact not only on Tachikawa but also on the entire Tama area. With that in mind, I would like to express my commitment to building a company that continues to contribute to the local community, and to ask for your support and cooperation in our endeavors.

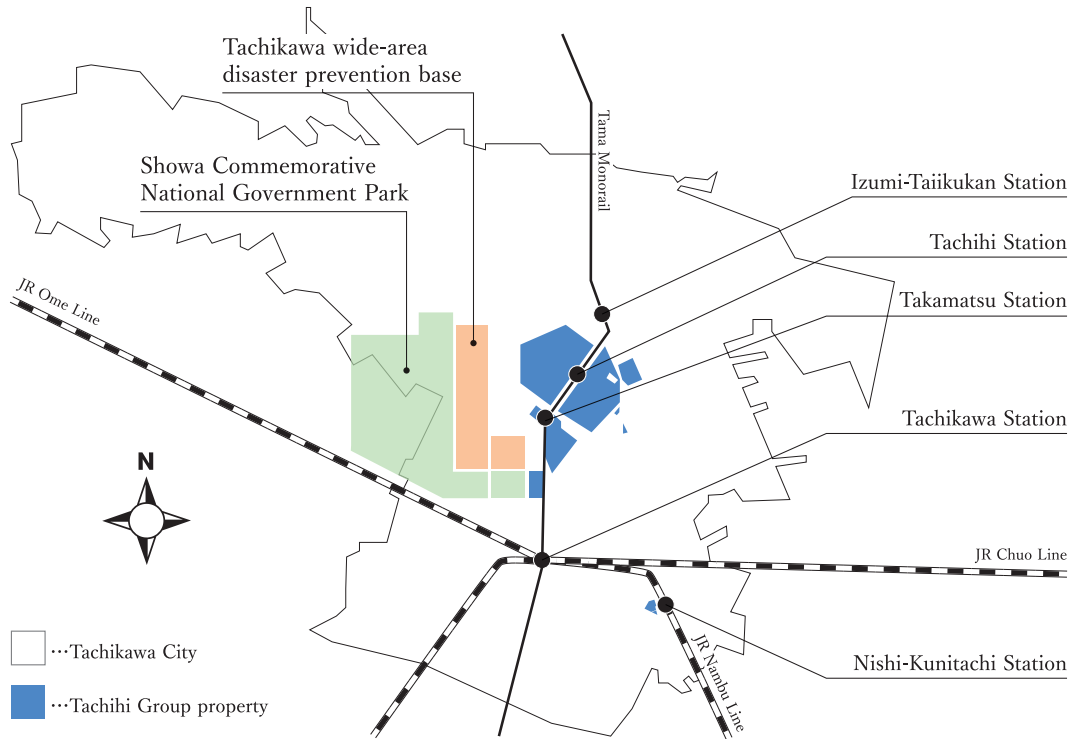

Tachikawa City is located in the heart of Tokyo's Tama district.
Near the center of Tachikawa, the Tachihi Group owns about 980,000 square
meters of land, which accounts for roughly 4% of the city.





Our Basic Policy for Real Estate Development (Three Principles)

Instituted on February 28, 2014

- I. Acknowledge the social responsibility arising from our real estate, its history, location, and scale while maintaining harmony with the community when redeveloping areas
- II. Establish a business foundation for facilitating sustainable support for the community
- III. Initiate and drive real estate development

The Tachihi Group consults with third party experts when drawing up plans for integrated property redevelopment. Due to the expansive property and complex restrictions arising from various land use agreements, each project is consequently a long-term development. These principles were formulated to maintain consistent redevelopment.

Location



Tachihi Station and Izumi-Taiikukan Station, both located at the center of our property, are highly accessible from the heart of Tokyo. It takes about 45 minutes to Shinjuku Station and about one hour to Tokyo Station from both stations.

Area

21 times larger than Tokyo Dome

Our properties span about 980,000 square meters, which is about 21 Tokyo Domes and make up about 4% of Tachikawa City. Most of our properties are located within two kilometers of Tachikawa Station located at the center of Tachikawa.

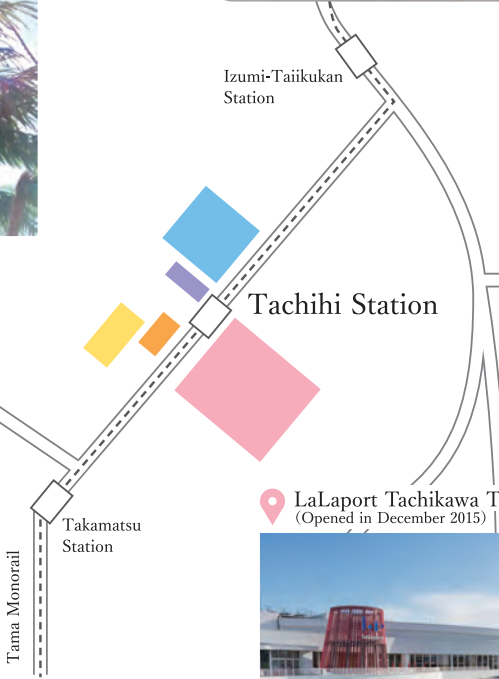

In February 2015, the Tachihi Group acquired about 39,000 square meters of nationally owned land located about an 8-minute walk from the JR Tachikawa Station North Exit. Believing in the potential of Tachikawa, where the city center and nature are proximate to each other, we are working on a large-scale joint development project. We propose a new way of living and a rich lifestyle sought by the post-2020 era as we aim to develop an urban subdivision of such impact that it will attract the world's attention to Tachikawa. From April 2020, we have begun to open a series of new developments, including a massive 2,500-seat event hall – the largest in the Tama area of Tokyo, a hotel with a 60-meter-long infinity pool that uses hot spring water, and an expansive yet comfortable office and shopping area.

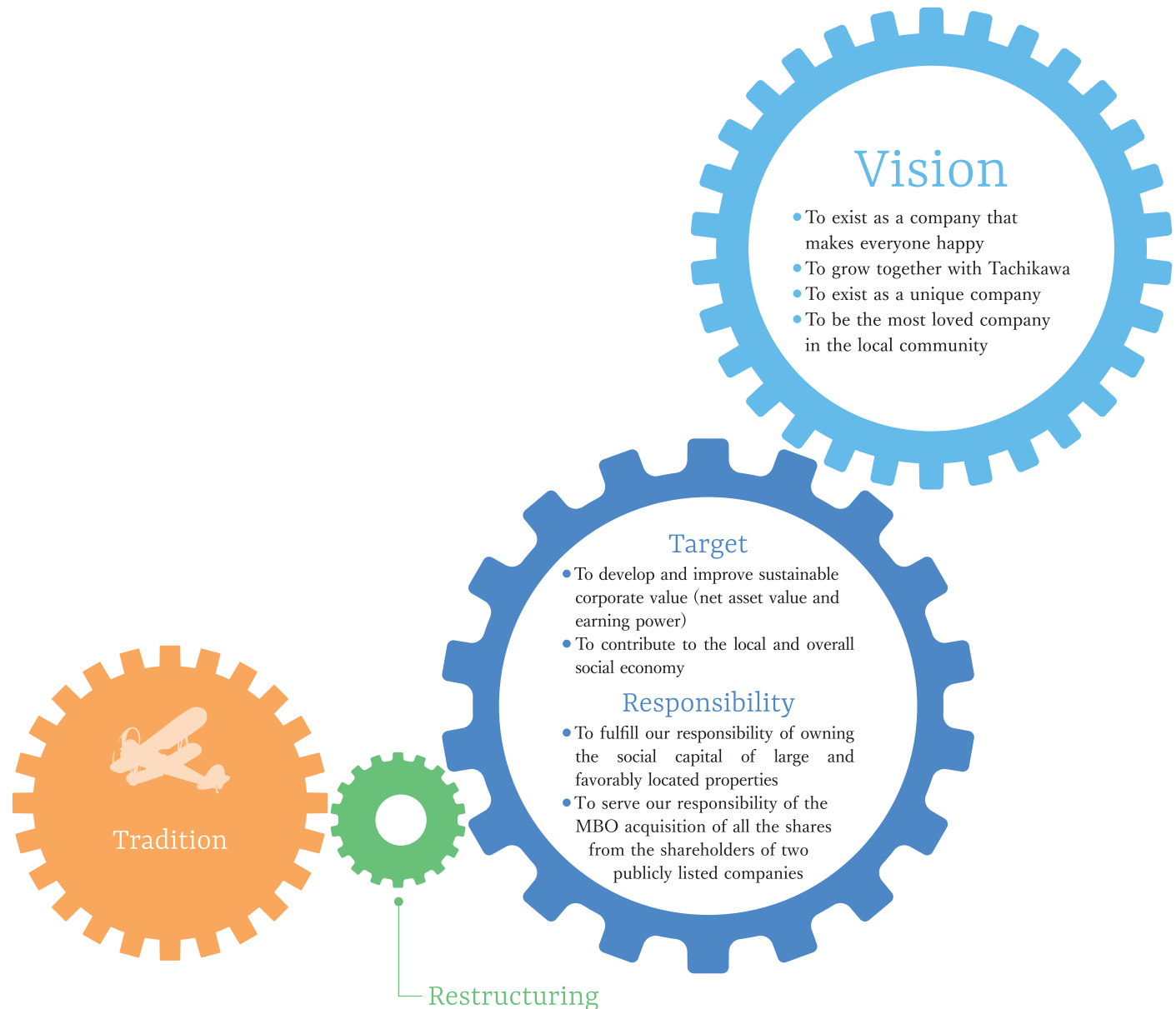


Growing success of Tachihi

The Tachihi Group was formerly known for its contribution to the national policy of Imperial Japan through aircraft manufacturing until the end of World War II.

Since then, the group has maintained its traditional values and has long operated in Tachikawa, after moving into the new field of real estate development in the post-war era. In 2012, the new Tachihi Group was born, aiming to redefine our brand and presence.

We recognize our unique social responsibility of owning massive and favorably located properties. And thus, it is a part of our duty to serve our neighbors through development projects and other activities in education, culture, art, sports, and many other areas.



In 2012, we merged two major group companies, which were divided at the end of the war, to achieve the integrated development of our property.

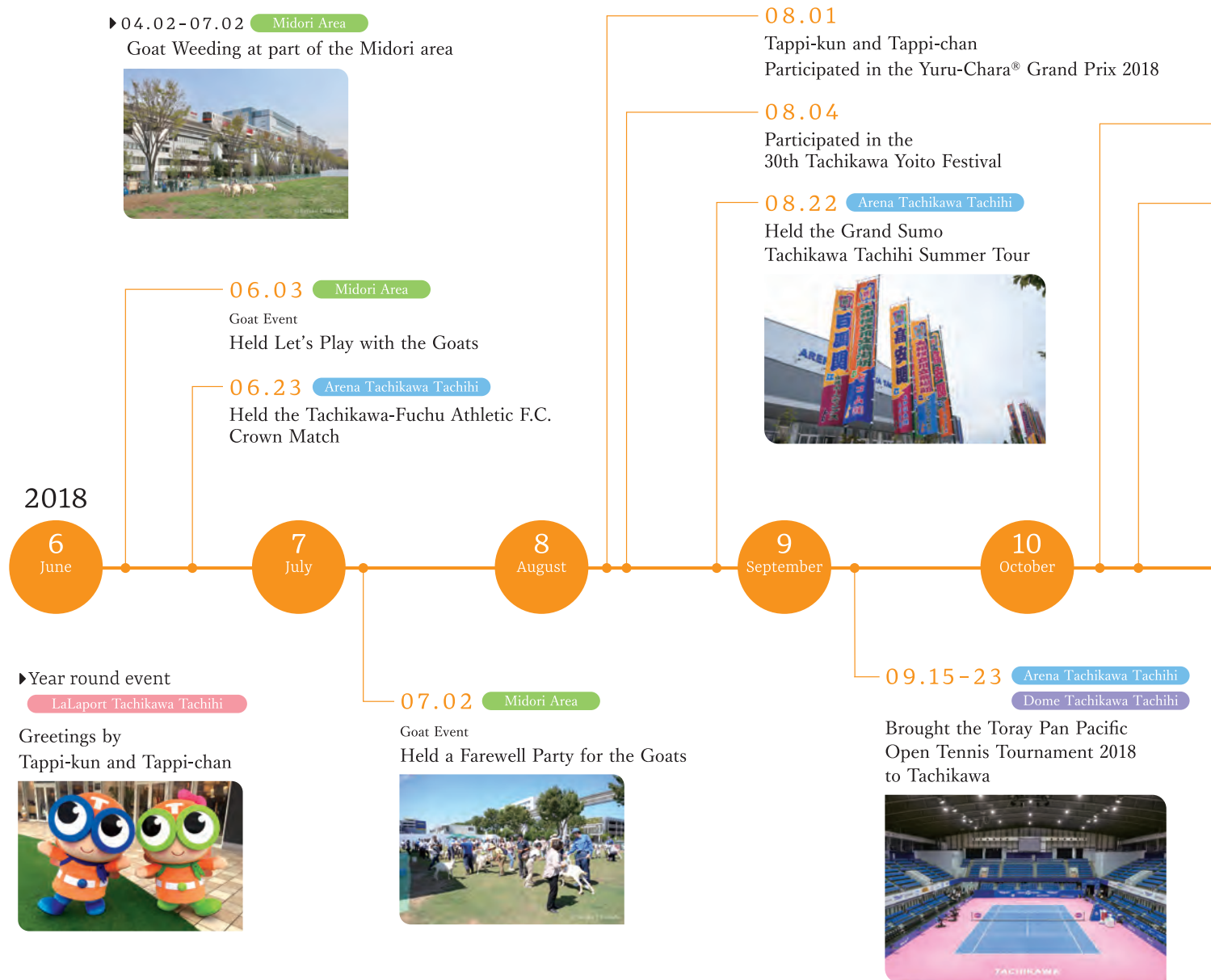

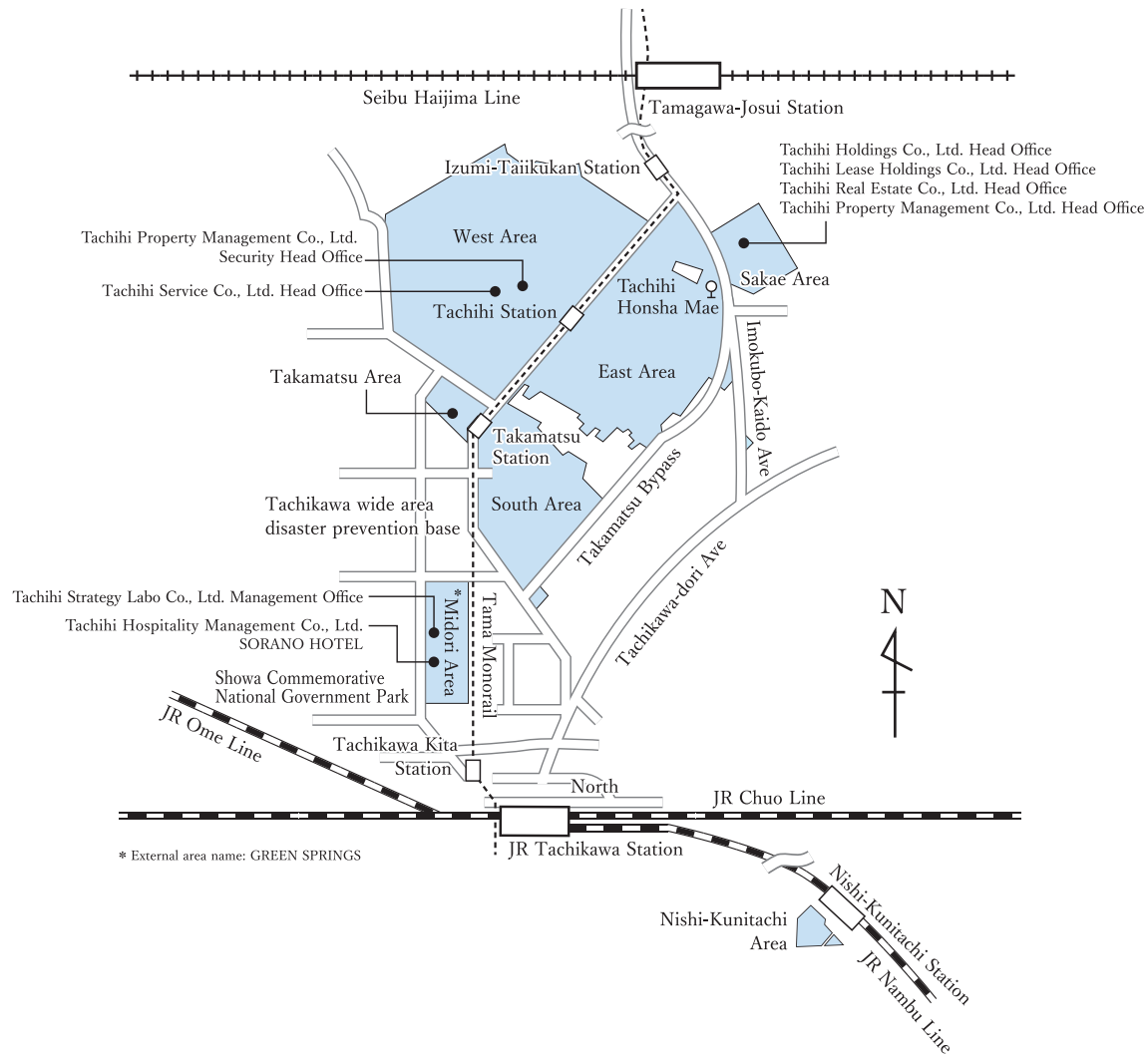
